

**Electronics Repair Waiver**

I authorize Stellar Computer Repair (hereafter SCR) to perform work on my phone/laptop/computer/electronic device. I understand SCR is not an authorized service dealer. Further, I agree to release, indemnify, and hold harmless SCR from liability for any claims or damages of any kind or description that may arise from any repair/work performed on my device, even if caused by negligence of SCR or its agent. I understand that SCR is not responsible for any data loss, which may occur as a result of work done on my device.

\_\_\_\_\_ I certify that I am the expressed owner of the device described on this document. In the event that I am found not to be the true expressed owner of this computer system, I assume all liability for any claim made as the result of the technical support rendered by SCR on the device, including those claims which assert negligence on the part of SCR.

\_\_\_\_\_ I understand that repair by SCR may void manufacturer warranties for this device. Water and dust resistance will be voided. SCR does not assume any liability or warranty in the event that the manufacturer warranties are voided.

\_\_\_\_\_ I understand that SCR can not guarantee the success of every repair, in the event of an unsuccessful repair attempt, we will typically just charge for the cost of any parts used and waive labor charges, but that is entirely up to the discretion of SCR at the time of device pickup. Due to the unpredictable nature of liquid with electronics, there is a chance your water damaged device may not be able to power up after cleaning. We are not responsible for any damage or data loss arising out of any attempt of liquid damage repair.

\_\_\_\_\_ I expressly waive all claims against SCR for any damages to this device or data that are incidental to the repair/support rendered by SCR. I Will not hold SCR responsible for any data loss arising out of services performed under this agreement. We recommend that you backup all information stored on the device being repaired.

\_\_\_\_\_ I certify that I will pay, in full, for the services rendered on this device at the rate of \$50/hour plus cost of parts plus tax. When dropping off your device, we will provide a free diagnostic and estimated cost. If after beginning repair, more damage is found on the device, we will allow you to either cancel the repair by paying for any parts and labor already expended, or to agree to the increased price. We will provide a breakdown on the cost of each part replaced on request. Do you want any replaced/broken parts returned to you? \_\_\_\_\_

\_\_\_\_\_ If you do not claim your device and pay in full within 30 days after being notified that your device has been repaired, SCR will consider the device abandoned and it will become the property of SCR.

\_\_\_\_\_ SCR provides a 60 day warranty on all parts we sell/replace. This warranty only covers repairs performed by us. The warranty does not extend to customer negligence or problems other than what was repaired. Warranties will only be acknowledged if a receipt is provided. Warranty is not transferable to other devices. I acknowledge that if I bring my own part, SCR does not express or imply any warranty.
